- Treasurer Report: M Ireland
 - Income is ahead of expenses for the year to date, largely because expenses are below projections.
 - Budget will start diving into the red compared to projections later this year as income we planned on does not materialize
 - PPP funds received and will start being used for payroll starting June 19

- BUDGET

 - Cancelled fundraisers

 - Services are different
 - Going to recalculate budget for 2020 2nd half and 2021 then have a budget only meeting
- **REOPENING**

 - Discussion about offering these services by reservation at a future date
 - Board supports the policy to only allow building access to people wearing a mask.
